Progress to achieving the three million student mobility target




Reaching the three million mobility goal

Growth in staff mobility numbers from 2007-08 to 2010-11








Erasmus for All: starting points


- Show EU added value show it is better to spend a € on the European level than at home!
- Relevance: link policy and programme show systemic impact by putting our money at the service of our policies
- Sustained impact at different levels: individual, institutional, systemic/policy
- Simplification, rationalisation
- Solid basis but adaptation and innovation







A streamlined architecture : 3 Key actions





KA1 Learning mobility of individuals - Higher Education-

- <u>Credit mobility:</u> <u>International opening of</u> <u>Erasmus,</u> more mobility of students and staff between EU – non EU in both directions
- 2. <u>Degree mobility:</u> <u>Joint Master courses</u> of excellent quality offered by consortium of EU/non EU universities to attract the very best students worldwide
- 3. <u>Student loan guarantee:</u> to boost degree mobility within Europe

Credit learning mobility of students (short cycles/Bachelor/Master/Doctorate) + HE staff Mobility

NEW: Erasmus opened to 3rd countries in both directions (where possible) for studies, traineeships, staff teaching and training

Grants for Joint Master Courses Continuity: Erasmus Mundus Action 1

Master Student Loan Guarantee NEW – 330.000 students



KA2 Cooperation for innovation - Higher Education-

- 1. <u>Erasmus Strategic</u> <u>Partnerships:</u> more intense cooperation between institutions.
- 2. <u>Knowlegde Alliances:</u> structure partnerships between HEI and businesses
- 3. Specific support with <u>neighbourhood countries</u>: More cooperation between universities for capacity building and more student and staff mobility.
- 4. <u>Rest of the world:</u> More cooperation between universities in the EU and rest of the world for capacity building.

Cooperation with the rest of the world

Mobility limited to HEI staff to achieve projects' objectives



- Sectoral & cross-sectoral structured cooperation (education, training & youth organisations + other relevant stakeholders) to develop and/or implement innovative practices leading to high quality teaching, training and learning and youth work, institutional modernisation and social innovation
- Activities ranging from small scale projects (i.e. allowing access for newcomers) to more ambitious, larger scale projects
- Balance of bottom-up and top-down: project ideas from grassroots/institutional level, within parameters set at EU level
- □ Fully decentralised management to enable better consideration of the national context and achieve maximum impact
 → targets set at national level







- To support HEIs to achieve the objectives set under the Commission HE Modernisation Agenda
- Action should result in the transfer, development and implementation of innovative practices at institutional, local and regional level



- Enhance quality of teaching and relevance of learning offer by developing new and innovative approaches
- Raising labour market relevance of study programmes and qualifications
- Foster provision and assessment of key competences
- Promote take-up of innovative practices in HE
- Facilitate transition of learners between different levels
 & types of education
- Strengthen integration of HEIs in local/regional development
- Prevent drop-out, facilitate access and inclusion of nontraditional learners

PARTNERSHIP & DURATION



- Benefit from the different experience, profiles and specific expertise and produce good quality results → partnerships should involve the most appropriate and diverse range of relevant partners, depending on the nature of the activities, their size; etc.: HEIs; enterprises; SMEs; local and regional authorities; research institutions; NGOs; VET providers; adult education providers; training centres; European networks; social partners; chambers of commerce, foundations, etc.
- Partnerships can last 2 or 3 years, depending on the objective of the project and on the type of activities foreseen over time



Large flexibility, as long as activities are the most appropriate to reach the specific objectives of the project Develop, test, adapt and implement innovative practices:

- Joint study programmes & joint curricula, IPs & common modules – including e-modules
- project-based TN collaboration between enterprises & students/staff at HEIs
- Pedagogical approaches and methodologies
- Integration of a greater variety of study modes (distance, part-time, modular learning)
- New approaches to facilitate permeability between education sectors
- Engagement of HEIs with local/regional authorities to promote regional development
- Cooperation and exchange of practice between staff responsible



- Facilitate recognition and certification of skills and competences at national level by referencing them to EU frameworks (EQF/NQF)
- Transnational mobility activities → only if significant added value and need to realise the objectives of the project. Such mobility may include:
 - Blended mobility of students combining short term physical mobility (less than 2 months) with virtual mobility
 - Long term teaching assignments (between 2 and 12 months)
 - Short term joint staff training events

- Support the Open Method of Coordination, Higher Education <u>Modernisation Agenda,</u> <u>Bologna Process</u>.
- 2. Support development and implementation of <u>EU transparency tools</u> and EU wide <u>networks</u>

Policy dialogue with selected world partners:


- * foster exchange between parties on issues of common interest

Budget implementation architecture

Management by National Agencies: (65%)

- Learning mobility of individuals (excluding joint/double degree) also for the international dimension
- Cooperation for innovation and good practices: Strategic partnerships between education institutions or between youth organisations and/or relevant actors
- Centralised management by Executive Agency: (35%)
 - Learning mobility of HE students in joint/double degree
 - Cooperation for innovation and good practices: Knowledge alliances, Sector Skills alliances, Capacity building in third countries, IT support platforms
 - Support to policy reform: Support to open method of coordination, EU transparency tools, Policy dialogue
