

#### Country Profile



- >216million inhabitant (2022 NBS)
- To increase to >400M by 2050
- 36 State & Federal Capital Territory
- Multilingual, Multireligious and Multiethnic

#### Nature of Social Work



- Informal family oriented, social welfare, communal
- Varies from state to state or region
- Social work as a study programme in the University
- Transition from informal to semistructured
- Social workers, welfare officers, public administrators
- Role of Non-Government actors (NGOs)

#### Areas of Social Work



- Child protection
- Gender development ( domestic violence, gender abuse
- Disability
- Elderly care
- Poverty reduction

### Older Adults

- Defined as people age 65 or older (National Institute of Ageing)
  - In Nigeria (60years and above) with Life expectancy 55.44 years (2022)
  - National Senior Citizen Act 2018 (caters for older citizens 70yrs & above)
- 1 in 6 people in the world will be aged 60 years or over (WHO) • In 2050, 80% of older people will be living in low- and middle-income countries. (WHO)
- United Nation Decade of Healthy Ageing (2021–2030) • Age friendly environment, combatting ageism, integrated care & long term care.



### Care of Older Adults

- Family oriented
- Informal /semi structured
- No functional national policy on care of older person
- Proliferation of care homes / institutions

#### FIN LAND

• Municipal

• Formal care/structured

• National policy (National program on ageing 2030)

• Older person living at home model

## Changes & Challenges in Care for Older Adults

Data driven rather than empathy driven (people not numbers) Impact of low population growth (taxpayers) vs high unemployment

Globalization and Migration

• Pressure on caregivers or breakdown of family structure

Social issues rather than health issues

- Loneliness in old age
- Abuse (discrimination)
- Mental health

### Impact on Future of Social Work




